## **AMENDMENTS**

## to the Regulations on the application of degression factors to the marginal rates of airport charges in UE "International airport Zaporizhzhia"

The difficult situation in the world aviation caused by the COVID-19 pandemic, border closure and limitation of flights have led to a significant reduction in flights and a reduction in passenger traffic. In order to restore the former air traffic both within Ukraine and abroad, minimize the negative consequences for production and economic activities due to the spread of acute respiratory disease, as well as to encourage airlines as commercial partners of airports

- 1. To make amendments to **paragraph 2.1 of Section 2** "Procedure for application of degression factors to the marginal rates of airport charges" and to state them in the following wording:
  - 2.1 The maximum degression factors applied to the marginal rates of airport charges when an Airline operates **new scheduled flights** are set at the following amounts:

Note: The amount of the degression factor during the first and second year of new scheduled flights is 0,2, regardless of the volume of passenger departures. The amount of the degression factor for each subsequent year is determined depending on the volume of passengers' departure in the previous year for all new scheduled flights.

- 2. To make amendments to **paragraph 3.6 of Section 3** "Final provisions" and to state them in the following wording:
- 3.6 These Amendments on the application of degression factors to the marginal rates of airport charges in UE "International airport Zaporizhzhia" go into force from July 22, 2021.

<sup>\*\* -</sup> the degression factor to the marginal rates of airport charges shall be applied only to flights for which a degression factor has not been applied in accordance with Section 2 of this Regulation.
